It is to inform you that on receiving the Continuation Returns from the Principal, Govt. College for Woman Jind, on the basis of instructions/guidelines for admission in UG/PG courses for the Academic Session 2018-19 of Kurukshetra University, Kurukshetra circulated vide letter no. Regn/R-I/2018/5434-5893 dated 18.06.2018 by the KUK, the Convener of the Fee Committee has convened a meeting on 10.08.2018 to discuss the above issue. The Fee Committee has also discussed the letters issued by the Academic Branch vide letter no. CRSU/Acad./2018/4967-5098 dated 07.07.2018 and letter no. CRSU/Acad./2018/5442-5573 dated 23.07.2018 regarding the instructions/guidelines for admission of various courses for the Academic Session 2018-19 including various types of fees and letter of Registration Branch vide no. CRSU/R&S/2018/2263-2277 dated 03.08.2018 regarding submission of Registration Return for the Academic Session 2018-19 along with instructions/guidelines for admission in various courses for the Academic Session 2018-19 of Kurukshetra University, Kurukshetra circulated vide letter no. Regn/R-I/2018/5434-5893 dated 18.06.2018 by the KUK. The following recommendations of the committee have been approved by the Vice-Chancellor:

- 1. The fees/fine/schedule of Kurukshetra University, Kurukshetra may be adopted as same as that of Page no. 17, 18 and 29-34 of instructions/guidelines for admission in various courses for the Academic Session 2018-19 circulated vide KUK letter no. Regn/R-I/2018/5434-5893 dated 18.06.2018 for admission in UG/PG courses of Degree Colleges affiliated to CRSU Jind, because earlier these colleges were earlier affiliated with KUK.**
2. All other instructions/guidelines for admission in UG/PG courses, which are not mentioned in CRSU letters vide CRSU/Acad./2018/4967-5098 dated 07.07.2018, letter no. CRSU/Acad./2018/5442-5573 dated 23.07.2018 and CRSU/R&S/2018/2263-2277 dated 03.08.2018 will also be same as that of instructions/guidelines for admission in UG/PG courses for the Academic Session 2018-19 circulated vide KUK letter no. Regn/R-I/2018/5434-5893 dated 18.06.2018.
3. The Vice-Chancellor, CRSU Jind may reduce / waive off late fees, if any, in case of cogent reasons.
