On this decision of the State Government this University has taken following measures:

1. The vacation in the UTDs already started from 08.03.2020 will remain continue upto 31.03.2020.
2. Teachers of the respective Courses shall remain available as per the time-table through E-resources so that the students may discuss their problems of the courses through e-mail/mobile phones to maintain continuity in the teaching learning process.
3. All functions including workshops, conferences, seminars etc. stand cancelled.


