Prof. (Dr.) R.B. Solanki, the Vice-Chancellor of the University and Chairperson of the Executive Council welcomed the Hon'ble members of the Council. Thereafter, the Progress Report of the University was presented by the worthy Vice-Chancellor and Agenda items were taken up by the Registrar.

### **PROGRESS REPORT OF THE UNIVERSITY:**

(i) Smart University Campus-

CRSU, Jind has effectively implemented the MHRD initiatives for the Development of Smart University Campus which comprises-

- a) Swachh Campus b) Paperless Campus c) Cashless campus
- d) Green Campus e) Renewable Energy
- (ii) UGC 12(B) Status-

The UGC Committee unanimously recommends 12(B) status to CRSU, Jind. Remarkable achievement of the University as no other university in Haryana State, got it in three and half years of its life.

(iii) Recognition by NCTE-

B.P.Ed and M.P.Ed. Courses of the University got recognition by Central body, NCTE, MHRD, Govt. of India.

(iv) Digitalization of University-

20 institutes were selected for the VISAKA Award by MHRD, Govt. of India and CRSU, Jind is the only University got selected for the award in Haryana state Govt. out of 4500 institutes/Universities/IIT's on the basis of All India survey of significance digital initiative.

(v) Social Outreach Programme-

University has adopted 6 Schools of Jind District under Social Outreach Programme in which its NSS unit is actively working.

(vi) Academic Audit of Departments -

In order to bring quality improvement in the academic standards of the University Teaching Departments and the initiative of Hon'ble Vice Chancellor, academic audit of the departments by outside experts have been initiated recently in which curriculum, library books, examination related issues, preparedness of teachers to assess academic delivery etc. is being judged and suggestions being implemented. Academic audit has already been completed in the Departments of Commerce, Managements, Computer Science and Applications.

 (vii) All Haryana Centralized B.Ed counselling-University has successfully completed centralized admission/counselling for All Haryana B.Ed admissions without a single complaint for third year in a row.

The Council appreciated the efforts of Vice Chancellor and the University fraternity over the academic and infrastructural development made in the University. The Council also appreciated the efforts done by the University to come up with high standards of higher education at UTD's. The members also appreciated all the steps taken by the University to improve the level of education in all colleges affiliated to CRSU, Jind in terms of admissions, selections of staff members and inspections.
