The Committee discussed the proposal vide Ref.No. IEMSP/CRSU-JIND/DP/2019 dated 07.07.2019 (Annexure–VII, Pages-18 to 24, already circulated) of Rs. 47,02,500/- plus GST as applicable submitted by M/s Inter Event Management Services Pvt. Ltd., New Delhi, which has also organized Inaugural Ceremony of permanent campus of Shri Vishawkarma Skill University, Palwal. After detailed discussion and deliberations with Sh. Harbans Nagpal, Director and other two (02) representatives of the company, the Committee unanimously recommended that the work for Event Management of 2<sup>nd</sup> Convocation of the University scheduled to be held on 22.07.2019 may be awarded to M/s Inter Event Management Services Pvt. Ltd, New Delhi on negotiated rates of Rs. 37,00,000/- (Rs. Thirty Seven Lacs) plus GST as applicable as per the details mentioned in the revised proposal no. IEMSP/CRSU-JIND/DP/2019 dated 11.07.2019 (Annexure-VIII, Pages-25 to 31, already circulated).
