At the very outset Professor R.B. Solanki, Vice-Chancellor welcomed the members of the Executive Council and appraised the House regarding development of the University.

**THE MINUTES OF THE MEETING ARE AS UNDER:**

1. Confirmed the minutes of the last meeting (20<sup>th</sup> Meeting) of the Executive Council held on 27<sup>th</sup> May, 2020 circulated vide letter No. CRSU/ACAD./EC-20/Minutes/2020/1033-47 dated 27.05.2020.

**Resolved that the minutes of the last meeting i.e. 20<sup>th</sup> meeting of Executive Council held on 27.05.2020 be confirmed.**

**Note:**

Regarding confirmation of Resolution No. 14 of 20<sup>th</sup> meeting of Executive Council held on 27.05.2020, the Council perused the complaint of Sh. Jagdeep Kaushik received through a e-mail, letter of DGHE, Haryana, Panchkula and others. On the complaint of Sh. Jagdeep Kaushik a letter from O/o Director General Higher Education, Panchkula bearing no. 7/32-2020 UNP(2) dated 29.05.2020 was received in this University to hold the promotion process who was appointed in the Advt. No. 6/2016 dated 17.06.2016 on the post of Superintendent as to maintain the status-quo till the final decision of the vigilance enquiry in the matter. The said letter was thoroughly examined and a reply



was sent to DGHE, Haryana, Panchkula vide this office letter no. CRSU/Estt./2020/494 dated 16.06.2020, wherein it was clarified that Sh. Anoop Singh has joined on his promotional post as Assistant Registrar on 27.05.2020. Subsequently, vide this office letter dated 19.06.2020, it was again clarified that the said Vigilance Enquiry was not against Sh. Anoop Singh as the Vigilance Enquiry was on the complaints filed by Sh. Dhirender Saini S/o Sh. Balbir Singh and Sh. Ishwar Das Kaushik F/o Sh. Jagdeep Kaushik "Complaint regarding Irregularities and Corruption by the Vice-Chancellor in Chaudhary Ranbir Singh University, Jind" (Copy attached as Annexure-I) including non-preparation of waiting list in various Non-Teaching appointments against Advt. No. 06/2016.

Furthermore, Mr. Jagdeep Kaushik had also filed a CM-5632-2020 in Hon'ble Punjab & Haryana High Court for staying of order dated 27.05.2020 regarding promotion of Respondent No. 5 to the post of Assistant Registrar, wherein the State Government/DGHE was also the party as Respondent No. 2. The Hon'ble High Court after hearing of applicant/ petitioner at length and taking into cognizance all the facts of the case, vide its orders dated 13.07.2020 "The instance application is disposed off with the observation that orders dated 27.05.2020 vide which respondent No. 5 has been promoted to the post of Assistant Registrar would be subject to the final outcome of the writ petition" (Copy attached as Annexure-II) and the same was communicated to O/o DGHE vide this office letter dated 27.07.2020 but no communication was received from O/o DGHE, Haryana after the orders of Hon'ble High Court. Against the confirmation of this resolution Prof. Sandeep Berwal has given his verbal dissent. Therefore, the Council resolved that the decision on Resolution No. 14 of the 20<sup>th</sup> meeting of Executive Council held on 27.05.2020 be confirmed.

2. Reported the action taken, wherever required on the various decisions taken by the Executive Council in its 20<sup>th</sup> meeting held on 27<sup>th</sup> May, 2020 for information and suggestions, if any.

**Resolved that the action taken report on the decisions taken by 20<sup>th</sup> meeting of the Executive Council held on 27.05.2020 be noted.**

3. Considered the recommendation of Finance Committee made vide resolution no. 5 of its 8<sup>th</sup> meeting held on 09.09.2020 in respect of the Annual Account for the financial year 2018-19.

**Resolved that the recommendation of 8<sup>th</sup> meeting of Finance Committee be approved.**

4. Considered the recommendation of Finance Committee vide Resolution No. 6 of its 8<sup>th</sup> meeting held on 09.09.2020 in respect of the revised Budget Estimates for the financial year 2019-20 and Budget Estimates for the financial year 2020-21.

**Resolved that the recommendations of 8<sup>th</sup> meeting of Finance Committee be approved.**

5. Considered the Annual Report 2019 for consideration and recommendation to the Court.

**Resolved that the Annual Report 2019 be approved.**

6. Considered and approved the confirmation of Dr. Sandeep Berwal on the post of Professor (Education) w.e.f. 11.11.2017 on satisfactory completion of his probation period of one year after making the modification in the following Resolution No. 46 dated 16.11.2017 by keeping the rules of confirmation in view:

Resolution 46: The Council considered and approved that Dr. Sandeep Berwal has completed his probation successfully. He shall be automatically confirmed to the post w.e.f. the date on which he gives off his claim of E.O.L. (retaining lien) from BPSMV, Khanpur.



The case of confirmation of Dr. Sandeep Berwal on the post of Professor (Education) w.e.f. the date on which he gives off his claim of EOL (retain lien) from BPSMV, Khanpur Kalan as approved by Resolution No. 46 of its meeting held on 16.11.2017 is not covered under the rules of confirmation of KUK as well as Haryana Civil Services (General) Rule 2016. Therefore, the case was discussed in the house in detail in view of the rule of confirmation of Haryana Civil Services (General) Rule 2016 wherein it was clearly mentioned that he shall be considered for confirmation after successful completion of probation period of the post of subsequent appointment. Further, at the time of eligibility for confirmation on that post he shall have to exercise his option either to opt for his confirmation on the new post or to revert back on his previous post within a period of three months from the date of issue of notice, failing which it shall be deemed that he opts to be confirmed on the post of subsequent appointment. After the receipt of option or expiry of the prescribed period, orders shall be issued accordingly by the competent authority. The option once exercised shall be final. But in the aforesaid case, this procedure was not adopted. Hence, it was resolved that now one week's time may be given to Prof. Sandeep Berwal for exercising aforesaid option otherwise after expiry of this period, he will be confirmed in this University from that date.

**Prof. Sandeep Berwal left the house during the discussion.**

7. Reported the action taken by the Vice-Chancellor under section 23(4) regarding appointment of Sh. Sanjay Nandan as Adjunct Faculty in the Department of Mass Communication, CRSU, Jind initially for a period of 6 months from the date of his joining.

**Resolved that the above action taken by the Vice-Chancellor be noted.**

Since this issue is a personal, the extension can't be stopped. Therefore, it was resolved that the above action taken by the Vice-Chancellor be noted.**

After detailed deliberations, the committee resolved that:

1. Online examinations may be conducted with live proctoring. The live proctoring may be image based or video based. Video proctoring may be preferred, if technically feasible and cost is admissible within budget, otherwise exam may also be conducted through image based proctoring.
2. The online examination may have Objective / Descriptive / both type questions. But for particular course the pattern may be same for online and offline mode.
3. For descriptive type questions in online examinations, the students may be provided an option of uploading the hand written papers.
4. As the work involved is highly confidential in nature, therefore, the agency may be hired under clause 11.4 of the University Account Code. The agency hired may have experience in same field. The option of public sector agency may also be explored, if time allows.

6. The payment may be made strictly as per University Account Code.
