4. Four-Year Integrated Courses in Teacher Education

5. PG Diploma in Guidance and Counselling

The Chairperson of the department has proposed that if above proposal is considered and approved by the Academic council, then a committee may be constituted to work out the requirement of Teaching and Non-teaching staff so that the same may be sent to Govt. of Haryana for its sanction. Thereafter, the National Council for Teacher Education may be approached for recognition of above courses. The matter was placed before the Vice Chancellor who has ordered that the same shall be placed before the AC and EC for consideration and approval (Annexure –XX, Page No. 75 to 79, already circulated).

RESOLUTION: Considered and approved. It was unanimously resolved that proposal may be sent to the State Govt. for creation of the post. The Vice Chancellor be authorized to constitute a committee to give the recommendations for creation of post and requirement of infrastructure for above courses.

36. To consider and approve the norms, guidelines & curriculum of Post Graduate Diploma in Rehabilitation Psychology being run in Education Colleges of Haryana w.e.f. Academic Session 2015-16 as recommended by the Board of Post Graduate Studies & Research in Psychology (placed on table).

RESOLUTION: Considered and approved.

37. To consider and approve the syllabi of M.A. English (3rd and 4th Semester) being run in the department of English w.e.f. Academic Session 2015-16 (placed on table).
