Minutes

of the PGBOS&R Meeting held in Department of English of CRSU, Jind on 19-08-2019

A meeting of the Post Graduate Board of Studies and Research of the Department of English, Chaudhary Ranbir Singh University, Jind was held at 11:00 AM on 19th August, 2019 in the office of the Chairperson, Department of English. The Following Members were present:

- 1. Dr. Jyoti Sheoran, Chairperson, Department of English, CRSU, Jind.
- 2. Prof. Umed Singh, Department of English, CDLU, Sirsa.
- 3. Dr. Manju Ailaiwadhi, Associate Professor, B.R.A.C. Delhi, University, Delhi.
- 4. Shri Satyawan Malik, Associate Professor, Govt. PG College, Jind.
- 5. Shri. Pardeep Sharma, Associate Professor, Govt. College, Safidon.

The following agenda were discussed:

- 1. The Paper 10- Communication Skills needs to be divided into five Units.
- 2. Introduction of new papers in the syllabus given below
 - a) A History of English Literature
 - b) Research Methodology and Dissertation & Viva Voce.
 - c) Indian Vedic and Classical Literature
- 3. Approval of the list of experts for Question Paper Setting and Evaluation, Dissertation Evaluation for M.Phil, and Post Graduation, Viva Voce, etc.
- 4. Introduction of M.Phil Course
- 5. Introduction Ph.D in the Department.

fter a thorough discussion on each of the items listed in the agenda given above, the ommittee unanimously took the following decisions:

- 1. Agenda No. 1: The 10th paper- Communication Skills is revised and divided into five units. A copy thereof is attached herewith.
- 2. For Agenda 2(a): The introduction of paper on A History of English Literature (Part 1 and Part 2) is recommended by the committee. The paper A History of English Literature (Part 1) should be introduced as an optional paper (Elective) in Semester I and A History of English Literature Part 2 of may be introduced as optional paper in Semester IV.
- 3. Members also recommended, in American Literature Part-1, that the following sections from Song of Myself by Walt Whitman are recommended for reading: Sections- 1, 6, 20, 52.
- 4. Regarding Agenda 2(b): the committee recommended that the new paper on Research Methodology may be introduced as a compulsory paper in Semester 3 in place of Colonial and Post- colonial Writing Part I. In Semester IV Research Dissertation and Viva Voce shall be introduced as a compulsory paper carrying 60+ 40 marks respectively. The length of the dissertation would be 40 to 60 pages. The topics of dissertation and Research Supervisor shall be allotted to

- students by the Chairperson of the department. The viva voce will be conducted by outside experts. The paper Colonial and Post-colonial Writing would be added to the list of Elective Papers in Semester IV.
- 5. The members also recommended that it is not feasible for Colleges to teach Open Elective to their students as in many colleges only one course is being run in Post Graduation so it is not possible for their students to take up an interdisciplinary paper under the CBCS scheme. Therefore CBCS scheme in Affiliated Colleges be not introduced. Literature and Gender Part 1 may be introduced in Semester III in place of interdisciplinary subjects.
- 6. Regarding Agenda 2 (c) the Paper on Indian Vedic and Classical Literature may be introduced as an elective paper in Semester IV. The copy of the syllabus has been attached herewith.
- 7. Regarding Agenda 3 List of Experts for Paper Evaluation, Exam Paper Setting, Dissertation Evaluation for M.Phil. and Post Graduation, Viva Voce, etc. was approved by the members.
- 8. Regarding Agenda 4 the committee strongly recommended that M.Phil English Course may be continued in the department.
- 9. Regarding Agenda 5: the committee recommended the introduction of Ph.D in the Department. Though there is no regular faculty in the department, Dr. Jyoti Sheoran is a regular employee of Directorate of Higher Education, Haryana, who has been on deputation in the University since 2015 as an Associate Professor in the Department. Thus, PhD Programme can be initiated under her. Also, a co-guide may compulsorily be associated for each prospective research scholar from other sister Universities. In case Dr. Jyoti Sheoran joins some other institution or a regular faculty joins the University then she shall act as co-guide for the research scholar and the former co-guide will act as the research guide. The members suggested so keeping in view the interest of the prospective scholar as well as to cater to the persistent demand of local students who are eagerly awaiting the introduction of the course in the Department.
