INTRODUCTION

Chaudhay Ranbir Singh University was established by the State Legislature Act 28 of 2014 on July 24, 2014, CSRU has a sprawling campus of 75 acres situated 2 kilometres from Gohana Bypass, Jind. The university was established with the vision of imparting quality education by creating most conducive ambience for the production and dissemination of knowledge guided by innovative thinking, scientific enquiry, sublime human values, sustainable ecology, and democratic ethos. The aim of the University is the cultivation of citizens with a rich awareness of our heritage to lead and serve in every sphere of human activity.

SCOPE OF WORK:-

To conduct access audit of various buildings and University Campus in compliance with the Harmonized guidelines and standards as per RPWD Act 2016 and submit a report along with corrective measures and detailed estimate for the retrofitting of the infrastructures along with supporting documents (2 copies each). The agency shall also indentify the locations and type of signage boards interior, exterior and circulatory areas etc. The access audit is to be done for all the completed and under construction buildings and University campus as mentioned at **Annexure-I.**

ELIGIBILITY CRITERIA:

The agency should qualify for the following eligibility criteria and possess the required experience, resources and capabilities in providing services necessary to meet the requirements indicated in the Expression of Interest document. The agencies not meeting the necessary criteria will not be considered for further evaluation.

- 1. The Agency should be a registered body under relevant acts and should be in field of Disability affairs for a minimum period of 3 years. Copy of Registration documents of Agency is to be attached.
- 2. The agency should furnish the information as per **Annexure-II** supported by Work order and completion certificates from the concerned department.
- 3. An access audit team for the purpose of accessing a building structure/ space shall comprise of
 - a) Person experienced in Access Auditing
 - b) Person with Disability using Wheelchair
 - c) Person with Disability (Visually Impaired/Speech and Hearing)
 - d) Qualified Architect
 - e) A Civil Engineer/Planner

Profile of each individual to be attached along with EOI.

- 4. The agency should not be blacklisted by any Central/State government/Public Sector Undertakings. Undertaking to be given by the agency on its letter head.
- 5. The bidder must enclose the documentary proof of up to date GST return, Income Tax Return.

TERMS AND CONDITIONS

The agency should adhere all the instructions and submit all the relevant information and documents which has been specified in EOI. The submissions of the application which are not complying instructions will result in rejection.

The agency should not be blacklisted in last one year by any Central/State government/Public Sector Undertakings.

The agency shall bear all cost associated with preparation and submission of the application and all cost, if any, for subsequent selection process. The department will in no case be responsible or liable for these costs regardless of conduct or outcome of this selection process.

Amendments to this EOI may be issued by the department at the time, prior to the deadline of the submission. Such amendments will be posted in scd.tn.gov.in website in form of addenda/corrigenda. The amendments issued shall be deemed to form an integral part of EOI from the date of issue and shall be binding on the agencies. The department reserves right to accept or reject any proposal and annul the EOI process and reject all applications at any time prior to empanelment of agencies and reserve the right to reissue the EOI without the agencies having right to object such reissue.

Mode Of Selection:

The selection of the Agency will be based on the Qualifying of Eligibility Criteria, presentation and financial offer made by the agencies in front of the evaluation committee.

Delivery Period:

The access audit has to be completed and report is to be submitted within 120 days from the date of work order. The first 10 days will be for laisioning and coordination concerned department. The report shall have to be submitted within 90 days and detailed estimate for retrofitting of infrastructure is to be submitted within 30 days from the date of acceptance of report on Access Audit by the University.

Delivery Period Extension:

The supply order(s) shall be executed within the time specified in this regard. However, in case of force Majure / reasons beyond control of the supplier, he may make a written request to the Vice Chancellor for grant of extension for delivery period. The written request in this regard should clearly spell out such reason.

The Vice Chancellor, if he is satisfied with such reasons and further that he requested extension will not be detrimental to the interests of the university, may grant extension for a reasonable period for delivery of the goods. The supplier would be required to indemnify the university against any loss on account of downfall of the price during the extended period.

Penalty for delayed supply:

In the event of the delayed supply, if accepted, the Registrar will be competent to impose penalty @ 1% per day of the purchase order, provided that the entire amount of penalty shall not exceed 10% of the total amount of purchase order. The supply will be deemed to be completed on the day when 100 % supply is handed over to the indenter (in case of supply in installments) and its installation is done. An appeal against these orders shall, however, lie to the Vice Chancellor whose decision shall be final.

Rejection of incomplete Quotations:

Incomplete quotations such as unsigned quotations, late submitted quotation, conditional quotation, quotation not confirming to the eligibility criteria and Technical specification or with any vague term such as 'Extra as applicable', will be considered as rejected.

Taxation:

GST/Custom duty etc. indicating the rate of taxes, should be quoted independent of the ex-works price of the item and it will be paid as applicable under Government rules, if so quoted by the Supplier in the quotation, subject to the certificate in the bill as follows. "Certified that the GST/Custom duty charged in this bill is leviable under Government Rules". In the absence of any indication to taxation by the supplier, it is to be assumed that the price quoted includes tax elements and no claim for the taxes or statutory variations thereon should be entertained after opening of quotation. However, wherever exemption from GST/custom duty is applicable, the university will provide the exemption certificate; along with supply/purchase order itself. In case of imported goods the custom clearance is to be arranged by the supplier at his own level. Charges, if any, in this regard, however, need to be mentioned accordingly in the quotation itself. University will provide necessary documents for this purpose. In case the quotation is silent with regard to taxation and clearance charges etc, no such charges will be paid by the university.

Right to Bid rejection:

The University reserves the right to reject any or all offers at any stage without assigning any reason.

Mode of Payment:

<u>Stage –I</u> 40% payment of award value shall be released within 30 days of completion & submission of access audit report of each building/infrastructure separately and its acceptance by the competent authority.

<u>Stage –II</u> 70% of payment of award value shall be released within 30 days of completion & submission of detailed estimate as per HSR/NS items (as applicable) for retrofitting of each building/infrastructure as per Access Audit report and its acceptance by the competent authority.

<u>Stage –III</u> Balance 30% of payment of award value shall be released after submission of successful implementation/execution of work as per access audit report and its certification of compliance.

Evaluation of Financial bid:

The financial bids shall indicate the cost estimate bid of access audit for all the buildings and University Campus for the work comprising of Conduct Access Audit, Submission of Audit report with corrective measures and detailed estimate. Conditional Bid shall be liable to be rejected.

If there is discrepancy between the price/information quoted in words and figures, the price/information in words would be treated as final.

The agency shall quote the rate inclusive of all the taxes and charges for service required for the job.

Arbitration:

In case of any dispute both the parties will be bounded by the decision of the Vice Chancellor, CRSU, Jind as the arbitrator.

Jurisdiction:

All disputes shall be subject to Jind jurisdiction.

EVALUATION METHOD

The University will examine the application to determine whether the documents submitted are complete, whether the required information has been provided as per the EOI, whether the documents have been properly signed and complied the requirements. Only those agencies which comply with the eligibility criteria will be taken for further evaluation.

The Evaluation process to consider whether the agency has experience and expertise conduct the access audit. Minor infirmities, non conformities may be waived at the discretion of the University. The University will evaluate the applicants for the appointment of agency and will prepare a result on performance parameters and information furnished in the application.
