ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas the use of loudspeakers cannot be stopped during the election period as the loudspeakers are one of the means of election propaganda and imparting information to public. But at the same time, indiscriminate and unfettered, use of loudspeakers at odd hours and at odd places at very high volumes which have the effect of disturbing peace and tranquility and cause annoyance to the general public and sick persons and student community, in particular, cannot be permitted.

And whereas it is necessary to issue direction in compliance with Election commission's letter No. 437/6/INST/ECI/FUNCT/MCC/2024 (Campaign)/507, dated 2<sup>nd</sup> January, 2024, along with other concerned references regarding use of loudspeakers for Election Campaign.

Now, therefore, I, M. Imran Raza, I.A.S. District Magistrate, Jind in exercise of the powers vested in me by virtue of Section 144 of the Code of Criminal Procedure 1973, and all other power enabling me in this behalf, hereby direct and draw the attention of all the political parties, candidates and their workers, supporters and sympathizers that the use of loudspeakers in District Jind shall be strictly regulated as follows:-

- (i) A public address system or loudspeakers or any sound amplifier, whether fitted on vehicles of any kind whatsoever, or in static position, used for public meetings for electioneering purposes, shall not be used at night between 10:00 P.M. to 06:00 A.M.
- (ii) All loudspeakers whether used for general propaganda or for public meetings or procession, and whether used on moving vehicles or otherwise, shall be used between 06:00 A.M. and 10:00 P.M.
- (iii) All loudspeakers being used beyond the hours as prescribed above shall be confiscated along with all the apparatus connected with the use of these loudspeakers.
- (iv) It should be ensured by the Regional Officer, HSPCB, Kaithal that decibels of the sound generated by loudspeakers/amplifiers does not exceed the permissible limit as fixe under relevant law/guidelines and the same monitored by the Police, AROs of Assembly Segments, SDMs and RO, HSPCB in district Jind.
- (v) All political parties, candidates and any other persons using any loudspeakers on moving vehicles including but not restricted to trucks, tempos, cars, taxis, vans, three-wheeler scooters, cycle rickshaws etc. shall intimate the registration identification number of those vehicles to the authorities granting permission to use the loudspeakers and such registration identification numbers of the vehicles shall be indicated on the permits granted by the authorities concerned.
- (vi) Any vehicle on which a loudspeaker is used without the said written permit shall be confiscated forthwith along with the loudspeaker and all the apparatus used along with it.
- (vii) All political parties, candidates and even other person using a loudspeaker either on a moving vehicle or at a fixed place shall intimate to the:-
  - (1) Returning Officer of 3 Sirsa, 4 Hisar, 6 Sonipat PC and Assistant Returning Officers of Assembly Segments in district Jind.
  - (2) Local Police authorities, in writing, the full details of the permits obtained by the before using any of those loudspeakers. In the case of mobile loudspeakers,

the registration numbers of the vehicles shall also be registered by them with the Returning Officer, ARO of the concerned Assembly Segment and the local Police authorities.

- (viii) The authorities granting permits for use of loudspeakers and the local Police authorities to strictly enforce that no loudspeaker is used by anyone in violation of any of the above directions.
- (ix) No loudspeakers fitted on vehicles of any kind or in any other manner whatsoever shall be permitted to be used during the period of 48 hours ending with the hour fixed for the conclusion of the poll in any polling area. Even after the close of poll, proper law and order is required to be maintained till completion of election after the declaration of result.

This order shall be applicable in the entire area of the District Jind and shall come in force from the date of issuance till the process of General Election to Lok Sabha, 2024 is over.

The Superintendent of Police, Jind, Assistant Returning Officers of all Assembly Segments in district Jind, all SDMs in the district and RO, HSPCB, Kaithal will get these orders implemented in letter and spirit.

In view of the emergent nature of the order, it is being passed ex-parte and addressed to the public in general.

The order shall be promulgated in the area of district Jind by affixing its copies on the Notice Board of District, Sub Division, Tehsil Offices, Information & Public Relations Department, publication in the newspapers having circulation in the area through the office of the DIPRO, Jind and publicity may also be carried out through social media. DIO, NIC, Jind is directed to host this order on the official website of district, Jind.

Any violation of the above direction or non-compliance by the political parties, candidates and their workers, supporters and sympathizers shall be viewed seriously and action will be taken under Section 188 of IPC, 1860 along with other relevant provisions of law.

Any laxity on the part of any authority in the strict implementation thereof shall invite severe action against them for dereliction of duties.


