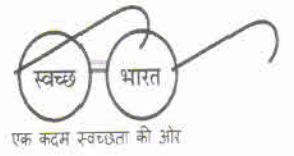

7. All disputes shall be subject to Jind jurisdiction.


