Subject: SCHEDULE FOR SUBMISSION OF CONTINUATION RETURNS OF UTDs FOR THE SESSION 2024-25.

Sir/Madam.

In continuation to the Notification issued by Academic Branch vide Endst. No. CRSU/Acad./S=11/2024/618=662 dated 15=07=2024 regarding promotion of the Students of LTDs to their next semester/ year for the session 2024-25; the Schedule for submission of Continuation Returns of University Teaching Department is as under:

- a) All UTDs will have to complete the process of online submission of Continuation Return of only Eligible Students and submit the hard copy of the same in Registration Branch within 40 days without fine from the date mentioned in the above referred notification.
- b) For remaining Students, Continuation Return of only eligible students can be submitted with late fess through online mode as well as to Registration Branch within 10 days each of the extended last date of promotion with late fee as fixed by the University from time to time.
- c) If any UTD'S submits the Offline Continuation Return after 40 days in respect of (a) above and 10 days in respect of (b) above. Continuation Returns should be submitted with the following applicable fine:

7	(i) For 8-14 days late after expiry of normal due date (ii) For 8-14 days late after expiry of extended due date	maximum of Rs. 50.000/-
3.	<ul> <li>(i) For -15-20 days late after expiry of normal due date</li> <li>(ii) For 15-20 days late after expiry of extended due date</li> </ul>	maximum of Rs. 1,00,000/-
