- Teaching and Non-Teaching posts may be filled up on urgent basis as it is the primary requirement for both NAAC Accreditation and smooth implementation of NEP-2020.
- Equivalency of the new Programmes may be ensured before starting the programme.
- The University may appoint Adjunct Faculty, Professors (Retd.), Visiting Faculty in the various departments and also organize extension lectures.
- The University plans to start some new academic programmes i.e. M.A.Sociology, M.A. Public Administration, Master of Hotel Management, M.A. Fine Arts, B.Lib., M.Lib etc. The members suggested to appoint/hire some professionals in concerned field as Artist in Residence, Senior Advocates, Industrialists etc.
- A teacher will publish at least two research papers a year.
- Some new programmes in foreign languages i.e. programme in French, German and Spanish may be started.
- A Data Center may be established.
- The University may plan to release its Magazine.
- An updated proforma for feedback of parents/students may be prepared.
- University Engineering College may be established in consultation with the State Government.
- Meetings of Finance Committee/Executive Council/Court may be conducted in the month of January/February every year, if possible.
- MoUs may be signed with prestigious academic research, innovation, planning and other bodies, nationally and internationally. FORMER 23
