* Schedule of Annual Fee shall start from date of meeting of Post Graduate Board of Studies and Research (PGBOS&R) and first installment is required to be submitted within one month of issue of letter of Registration. For further years, fee is to be submitted after the completion of one year from the date of the Registration.

Note: i. Fee once paid will not be refunded in any case.

ii. The Schedule Caste Students of Haryana whose family income from all sources is up to Rs. 2.50 Lacs per annum as prescribed by the State Govt. for Post Matric Scholarship and who produce, at the time Ph.D. Registration, the "Caste" and "Income" Certificate etc. issued by the Competent Authority and updated Parivar Pehchan Patra (PPP), are not required to pay any kind of fee and they shall pay a sum of Rs. 5000/- (Refundable) as security/caution money. The eligible SC Students will apply the Post Matric Scholarship forms on the concerned Portal. The Fee will be recovered from his/her Scholarship amount. In case, the students does not apply for Scholarship or is found not eligible for award of Post Matric Scholarship or being eligible he/she is not awarded Post Matric Scholarship due to one reasons or the other, and the fee is not deposited by the student to the University within seven days after receiving the Post Matric Scholarship amount through Direct Benefit Transfer (DBT) in her/his account, she/he will be liable to pay full fee alongwith late fine of Rs. 10/- per day subject to maximum Rs. 5000/- (Five thousand only). Degree will be issued only after submitting the No Dues Certificate (NOC)/Clearance of fees.
