

Criterion for creating Examination centre in self-financing B.Ed Colleges affiliated to CRSU Jind:

- The college must have minimum seating capacity for 200 students and has required furniture in good condition.
- The college must have Power Back Up (With Electrical-Generator) and Computation and Internet facilities with minimum speed of 2 MBPS.
- 3. The college must have printing facilities including computer printers and photocopier machine for successful implementation of SRPD (Secure Remote Paper Distribution).
- 4. The college must have strong room, separate toilets for boys & girls, drinking water availability and security arrangement.
- The college must have minimum 07 approved teachers other than Principal and non teaching staff for smooth conduct of examinations.
- 6. The college must be easily approachable.

On the basis of above criterion, the following process will be followed to create an examination centre in a self-financing B.Ed College.

- i. The self-financing colleges are required to apply to the Controller of Examinations, CRSU Jind for creation of Examination Centre in their college through prescribed application form along with application Fee of Rs 5000/- (Non- refundable) deposited in the account of the Registrar, CRSU Jind and an Affidavit (duly attested by Notary) as per Annexure-1 latest by 22/05/2017 till 5.00 PM.
- ii. The Examination Centre (s) may be directly created at the self-financing college (s) fulfilling the above mentioned criterion by the Vice-Chancellor, CRSU Jind on the recommendations of the Controller of Examinations

Or


The Vice-Chancellor, CRSU Jind may constitute a committee comprising of minimum two members on the recommendations of the Controller of Examinations to physically verify the information provided by the applicant before creating the centre.

iii. The TA/ DA and Honorarium @ Rs 1000/- per member per college inspected to members of inspection team will be paid by CRSU Jind

- iv. The concerned self-financing college in which the centre is created by CRSU Jind will have to deposit a centre fee of Rs 15000/- in the Account of The Registrar, CRSU Jind before commencement of Examinations.
- v. The college (s), from where the students are going to appear at examination centre (s) being created by CRSU Jind is / are required to deposit Rs 4000/- in case of annual examination system and Rs 2000/- per semester in case of semester examination system. These colleges should deposit the amount directly to the Principal of concerned college (s), where examination centre (s) is being created by CRSU Jind before the commencement of examinations. This amount is to be paid to cope up the miscellaneous at the examination centre (s) under the head of building charges/ furniture charges/ electricity and generator charges etc.
