In continuation to this office letter no. 30/43-2018 Co.(2) Dated:9th May, 2019, I have been directed to inform and request you that as per the decisions taken in the meeting of Registrars of the affiliating State Universities held on 09.05.2019 under the Chairmanship of Director Higher education the following decisions are being forwarded for your kind consideration and necessary action please:-

- 1. The online admission will start from w.e.f. 8<sup>th</sup> June 2019 (calendar time) and the last
- 2. From 2019-20 only two merit lists will be generate on the basis of self verified data provided by the applicant for all colleges with maximum validity of about 7 days after auto fetching primary data. The first "Merit list' will be displayed on 2<sup>nd</sup> July, 2019 and will be valid till  $6^{th}$  July, 2019 . Similarly, the second " Merit list" will be displaced on 9<sup>th</sup> July, 2019 and will be valid till 15<sup>th</sup> July, 2019. The waiting lists will be effective w.e.f. 15th July, 2019 and the classes for all courses i.e., new students and old students will commence from 16th July, 2019. In no case the admissions be allowed after 15th August, 2019 and in no case the Vice Chancellors will allow delay condoned after 22<sup>nd</sup> August, 2019 except in cases of hardships only.
- 3. The late fee w.e.f 16th July, 2019 will be as per the details i.e., Rs. 100/-from 16th to 24th July; Rs. 200/- from 25th July to 31st July; Rs. 500/- from 1st August to 8th August; Rs. 1000/- from 9th August to 15th August and Rs. 2000/- from 16th August onwards.
- 4. Necessary inputs for modification of application form may be supplied by the Universities to this office latest by Tuesday, i.e., 14th July, 2019 and the admissions

guidelines for under graduate courses will be issued to all affiliating colleges by 1.5° May, 2019 by each affiliating University.

- 5. The seats reserved for Outstanding Sport persons(sports quota) will be supernumeric seat(s) and will be notified by each affiliating University.
- 6. The decision on AIR category will be communicated separately.
