It is being informed to all the concerned Chairpersons/Incharge/Principals that the following are the provision (s) of penalty to ensure timely submission of Internal Assessment of students by the College & University Teaching Departments:

- Internal assessment/awards of each student without any fee must be submitted in examination branch of the University upto one week before commencement of the theory examinations
- 2. After the last date, Rs. 1000/- per day per course as penalty will be charged subject to maximum of Rs. 1,00,000/- (One lakh) per course from the college/University Teaching Departments.
- No Internal assessment/awards will be accepted after the date of declaration of result of the course.

Note: The last date of submission of Internal Assessment (without any late fee/penalty) of third semester students of affiliated college for which theory examination has been conducted in Feb-march, 2018, is March 31, 2018
