

In continuation to this office letter No. KW 30/3-2019 Co. (2) dated 07-06-2019, I have been directed to clarify that 10% reservation for Economical Weaker Section (EWS) will be 50% of the State Quota and will be 42.5% of the total intake (i.e. 50% of General Category out of 85% of Haryana domicile).
