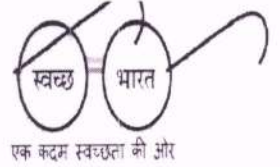

**Subject: -Guidelines including frequency of Inspections, Schedule of Inspections for Inspections for Degree as well as Education Colleges (both SFS & Govt./Govt. Aided) for continuation/extension of affiliation of the colleges affiliated with the University.**

Sir/Madam,

The following guidelines has been approved by the **Academic Council vide Resolution No. 47** in its 12<sup>th</sup> meeting held on **21<sup>st</sup> August, 2019** & **Executive Council vide Resolution No. 26** in its 18<sup>th</sup> meeting held on **26<sup>th</sup> August, 2019**:

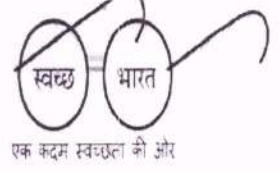
1. Frequency of Inspection
  - a. Provisionally affiliated colleges be inspected for extension of provisional affiliation in every academic session.
  - b. Permanently affiliated colleges be inspected for extension of permanent affiliation once in three years.
2. Schedule of Inspection

The following schedule be followed by the University for continuation in provisional affiliation:

- a. Deposit of continuation fee, Inspection fee, course extension fee, etc.: Up to **30<sup>th</sup> November** of previous academic year.
- b. Completion of Inspection by duly constituted committee: Up to **31<sup>st</sup> March** of previous academic year.
- c. Communicating the deficiencies indicating by the Inspection committee to the colleges: Up to **30<sup>th</sup> April** of previous academic year.
- d. Receipt of affidavit by Chairman/President/Secretary of the college management committee swearing that the deficiencies pointed out by the inspection committee will be removed within the time period stipulated by the Inspection Committee/University: Up to **15<sup>th</sup> May** previous academic year.

- e. Commuting to the college regarding continuation of affiliation: Up to 31<sup>st</sup> May of previous academic year.
3. There are separate proforma for Teacher Education Courses as per the requirement of NCTE. In this context, the committee recommends that one team may inspect all the teacher education courses run by a college of education and the inspection team members may be paid honourarium per course per member.
