Sub: Regarding Continuous Return for the Session 2017-18

Sir/Madam,

You are well aware that the last date of admission/promotion for the next higher class of NCTE courses i.e. B.Ed./M.Ed./B.P.Ed./M.P.Ed. etc. is already over on 20/08/2017. You are therefore, requested to send the online continuation return of the eligible students completed in all respect on RF-6 performa alongwith generated mandate fee and the hard copy of the same in the Registration Branch of CRSU, Jind within 40 days of the last date of admission/promotion, failing which the late fee will be charged as per university rules.

However, the Vice-Chancellor may consider to allow/to admit the continuation Return as a special case with late fee as decided by him.

FEES TO BE DEPOSITED TO UNIVERSITY BY AFFILIATED COLLEGES




