Sub: Submission of continuation fee, Extension fee and inspection fee for the session 2017-2018.

Sir/Madam

I am to inform you that the continuation fee of Rs. 50,000/-, course fee/Extension fee Rs. 20,000/- and inspection fee Rs. 20,000/- may be deposited in the university account i.e. 9941000100000259 before the expiry of last date i.e. 15th February 2017. The proof of deposited amount may also be submitted in the Colleges Branch.

After 15th February 2017 of the current academic session, 25% extra fee will be charged up to 15th March 2017.

After 15th March 2017 of the current academic session, 50 % extra fee will be charged up to 15th May 2017.

After 15th May 2017 of the current academic session, 100% extra fee will be charged up to 15th June 2017, failing which disciplinary proceedings regarding disaffiliation, putting the college in no admission category shall be initiated after 15 June 2017.

The Member of Inspection Committee shall be paid Travelling and Halting Allowance of the Class to which they are entitled according to normal rules, and in addition, an inspection fee. Rs. 2,000/- per visit/per member will be paid by the university. The college will have to arrange videography of the inspection.
