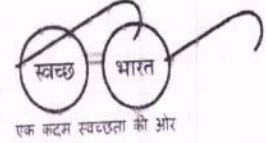

- In case results of the Even Semester are not conducted/declared in time, provisional admission in subsequent odd semester will be made and classes may commence **w.e.f. 4<sup>th</sup> August, 2020 of U.G. and P.G. courses** in the online and offline mode as per situation, subject to directions from the State Government, if any.
- The Principals of the affiliated colleges shall follow the guidelines of the State Government regarding admission schedule and they are also authorized to make minor changes/adjustments according to their local conditions at their own level, keeping in view, the condition of minimum 90 days in each semester and directions from the State Government.

**Note: This is a tentative schedule, it may be changed as per direction of UGC as well as State Government.**

The Academic Calendar(s) for NCTE/RCI approved Courses and rest of semesters shall be notified separately.


