**SHORT NOTICE INVITING QUOTATIONS FOR C.A.M.C. OF R.O.'s/ Water Purifiers**

Sealed Quotations are invited from the prospective bidders having reputation and experience for comprehensive annual maintenance contract of R.O.'s / Water Purifiers installed at Chaudhary Ranbir Singh University, Jind for a period of one year .

Work specification: CAMC in respect of R.O's mentioned below

The quantity may increase or decrease during CAMC period. The bidders may visit to inspect the machines upto 21.08.2020 during working hours of the University.

The terms and conditions of governing the maintenance contract, Performa of bid are illustrated in the Annexure- I and II respectively.

The bids will be opened on 25.08.2020 at 15:00 hrs in the presence of the members of the concerned committee and also in the presence of the contractors or their authorized representatives, if any, who wish to participate, in The Conference Hall, Teaching Block- I, CRSU, Jind. The sealed quotations with proper fees mentioned in annexure -I shall reach to office of the Registrar, CRSU, Jind upto 24.08.2020 by speed post or by hand.

This office reserves the right to reject any of the quotations received from the contractors, for any deficiency in the entries, without assigning any reason for the same. No correspondence will be made with the unsuccessful bidders.

## **Agreement**

1. CRSU, Jind is proposing to enter into a Comprehensive Annual Maintenance Contract (C.A.M.C.) for the period of one year from date .....to..... for all Water Purifiers and RO Systems installed in CRS University Campus. The rates to be quoted for the period from date of signing of deed agreement till the tenure. The contract may be extended further on good performance, subjected to mutual agreement of both the parties. The quotations shall not include any conditions whatsoever. In case, any conditions are included in the quotation the same may not be taken into consideration. The quotation in such cases is liable to be rejected. Clarification, if any, shall be obtained in writing from the CRSU, Jind before submission of the quotation.
2. In case of any complaint/ breakdown/fault in any equipment, the firm has to attend the fault within 24 hours of reporting on phone/FAX/ Email etc. failing which will invite a penalty as follows:
  - i) Attending the complaint between 24 - 72 hours of intimation- Rs. 200/-
  - ii) Attending the complaint between 4 days to 7 days of intimation- Rs. 1000/-
  - iii) Attending to complaint beyond 7 days - Rs. 2000/-
3. The CAMC is for preventive as well as for break down maintenance and includes repair and replacement of the following parts free of charge during the CAMC Period:-
  - (a) All kinds of Filters (b) Pre-filter candle (c) Compressor (d) Thermostat (e) Transformer (f) Relay (g) Carbon (h) Motors/ pumps (i) Other worn out parts etc. At least one replacement in a year for all Filters should be necessary.
4. If the Quotee fails to undertake the job satisfactorily at any period of time or withdraws his services permanently for more than three consecutive weeks, the CRSU, Jind has every right to cancel the contract and forfeit the Security Deposit without assigning any reason what so ever.
5. The quotation should be accompanied by a crossed Demand Draft/ Pay order for Rs. 10,000/- (Rs. Ten thousand only) payable to the Registrar, CRS University, Jind as Earnest Money Deposit (EMD) without which quotation will not be accepted. The EMD will not carry any interest. EMD of unsuccessful quotees/bidders will be refunded once the work is awarded. EMD of success quotee will be held as security deposit and will be refunded after successful completion of the C.A.M.C period.
6. The price quoted by the quotee/bidder should be firm and inclusive octroi, freight and forwarding charges, handling charges, loading insurance charges, any other tax/charges inclusive of GST.
7. It will be the responsibility of successful bidder to submit the treated Water Quality Analysis Report from any Govt. lab or any other reputed lab of all the RO Systems on quarterly basis.

8. The repair of equipments should be done as per schedule failing which CRSU, Jind reserves the right to get any other authorized party to service the machine and the difference in cost if any in such cases will be recovered from the supplier's bills or from the EMD/ Security deposit of the supplier.
9. The contractor has to maintain a register for the periodical inspections, which have to be undersigned by officer in - charge. The contractor should depute only qualified/experienced technicians for carrying out the preventive maintenance work.
10. The payment shall be released on half-yearly basis on completion of the respective part of year, against the bill provided by the party on due certification of satisfactory services by officer in-charge in CRSU, Jind. Half-year shall mean six months completion from starting of CAMC. Payment shall ordinarily be made in within 60 days of receipt of the goods/services along with pre- receipted bill (in triplicate), as well as on acceptance of the item/job card.
11. The rates to be quoted for the period from date of signing of deed agreement till the tenure.
12. If the tender is withdrawn by the quotee/bidder during the CAMC period, the EMD will be forfeited.
13. Supplier warrants that the items supplied for repair during CAMC under this contract are new, unused and shall have no defect, arising from design, materials or workmanship or from any act or omission of the supplier that may develop under normal use of supplied items.
14. After every six months bill will be raised by the company for making the payment along with log book of the machines. Payment will be made six monthly i.e. two equal installment of yearly amount on completion of every six months. After every six months, the bill will be raised by the company for making the payment mentioning clearly the serial No. of installment and year of the CAMC.
15. The firm shall be wholly responsible to their personnel deployed, for any injury or any medical problems sustained by them during work in the University.
16. Any additional visits during the contract period, as and when required in the event of any breakdown/ malfunctioning of the equipment on intimation in this regard by the CRSU is covered in CAMC.
