Dr. Jyoti Sheoran could not attend the meeting due to some unavoidable circumstances.

The Committee has considered the request of residents of Senior Faculty Houses and in light of Haryana Civil Services (Allowances to Government Employees) Rules, 2016 the Committee recommends the following:

1. The University has two types of accommodation namely Type D and Type E Houses. However, as per Haryana Civil Services (Allowances to Government Employees) Rules, 2016, the types of accommodation have been classified from Type I to V. The Committee recommend that the Type D and E accommodation of University are equivalent to Type III and IV accommodation as classified by State Government.
2. The License fee as prescribed in Haryana Civil Services (Allowances to Government Employees) Rules, 2016 may be charged/recovered from the residents of Type D and E accommodations i.e. Rs. 400 for Type D (Type III) and Rs. 500 for Type E (Type IV) accommodations.
3. The necessary changes in the University Residential Accommodation Rules may be made as follows:
