- Note:
 - 1. If the number of teaching days falls less than 180days (90 days in each Semester) in the Academic Session 2016-17 due to some unforeseen reasons, it would be the responsibility of each Department to make good the loss by arranging extra classes.
 - 2. Award of Degrees: Degree shall be awarded within 180 days from the date of notification of result.
 - In case result of the Even Semester is not declared in time, provisional admissions in case of ongoing Semesters will be made and classes may commence w.e.f. 22nd July, 2016.
 - 4. The Committee of the representatives of the State Universities in its meeting held on 07.04.2016 has authorized the concerned Universities to make minor changes/adjustment according to their local conditions of minimum 90 teaching days should be en each semester.
