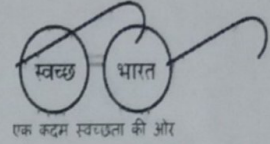



Note :- Normal Examination Fee for Re-appear (Regular) Students – Rs. 800/- and for Re-appear Ex-students- Rs. 1000/- per Semester.

1. The students who have passed first two semesters in two year course and first four semesters in three year course and having re-appear (s) in 3rd and 5th semester respectively (not more than 50% papers) may also appear in 3rd and 5th semester along with 4th and 6th semester respectively .The schedule of submission of re-appear form for 3rd and 5th semester in such cases will be same as that of 4th and 6th semester in that course.
2. Chairpersons of respective University Teaching Departments may also be requested to notify the schedule among the students of their departments and sent their Examination forms offline in one lot along with forwarding letter and cut list to the Examination Branch. The Examination forms as per requirement may be collected from the result Branch.
3. All the Principal of affiliated colleges are requested to fill online form on University Portal on given dates. The Portal will start from 11/03/2019.
4. If the number of teaching day falls less than 180 days in the academic session (90 days in each semester). It should be responsibility of each teacher to complete the syllabus by taking extra classes.
5. In the event of any last date for submission of examination forms falls on holidays the next working days will be deemed to be last date and no examination form will be entertained after the expiry of last date.


