- (vii) Faculty members who are not fully conversant with the Google meet platform may contact to System Analyst for hands or experience.
- (viii) The System Analyst and his team members will provide all technical support to the faculty members for smooth conduct of online classes.
- (ix) For any other clarification, Dean Academic Affairs office may be contacted.
