Sir,

With reference to your letter No. CRSU/REG/2015/221 dated 29.01.2015 on the above subject, I am directed to inform you that after scrutinizing of the documents submitted by the University, the following have been observed:-

1. The building of Teaching Block and Girls Hostel is not yet completed.
2. Sanctioned faculty is not as required under UGC 12(B) Rules i.e. at least One Professor, Two Associate professor and adequate No. of Assistant professors in each Department.
