1. Confirmed the minutes of the last meeting of the Executive Council held on 11th November, 2020 circulated vide letter No. CRSU/ACAD./EC-23/Minutes/2020/4078-4092 dated 16.11.2020.

Resolved that the minutes of 23rd meeting of Executive Council held on 11th November, 2020 be confirmed.

2. Reported the action taken on the decisions taken by the Executive Council in its 23rd Meeting held on 11th November, 2020.

Resolved that the action taken report of 23rd meeting of Executive Council held on 11th December, 2020 be noted.

3. Considered and approved the minutes of the meeting of the Committee held on 05.11.2020 to draft the Self Appraisal Proforma for Contractual Teachers/Assistant Professor (on contract).

4. Noted the action taken by the Vice-Chancellor for withdrawal of the approval of the proceeding of Dr. Sushila Saini for the post of Principal, DCS College of Education, Mehmoodpur Road, Gohana, Sonapat as the approval was granted to her on the basis of old qualification whereas the University had already adopted the new qualification of NCTE & its amendment and the same was notified by this office notification No. CRSU/CB/2017/4839-44 dated 22.12.2017 and also uploaded on the University website.

Resolved that the recommendation of the Academic Council be approved.

5. Reported the Status of the Temporary advance of Rs. 5,20,000/- availed by Prof. Sandeep Berwal, Department of Education in the capacity of Director, Youth Welfare in January 2018.

The Executive Council noted the status of temporary advance of Rs. 520000/- drawn by Professor Sandeep Berwal in the capacity of Director Youth Welfare which was to be got adjusted in the same financial year, but he did not do so. In spite of taking steps for adjustment of advance despite of issuing several reminders he started blaming on authority and others. Therefore, it was resolved that he be advised to get the said temporary advance adjusted within 15 days failing which it will be presumed that the amount of advance has not been spent for the purpose and the same will be recovered from his salary by the Accounts Branch.

Further resolved that he be advised not to blame others for his inefficiency or negligence towards his duties.

6. Considered and approved the Report of Enquiry Committee (to be placed on table in sealed envelope) constituted by the Executive Council in its 22nd Emergent Meeting held on 05-10-2020 in the matter of Prof. Sandeep Berwal (under suspension) for capturing the Conference Hall with the help of two relatives, creating quash and misbehaved the members of the Selection Committee for selection of Assistant Professor and Associate Professor in the Department of Physical Education.

The Executive Council considered the report of the Enquiry Committee constituted by it in its 22nd emergent meeting held on 05.10.2020 and found that Professor Sandeep Berwal has not appeared before the Committee after giving him invitation two times to present his case. Although his acts and behavior are unbecoming of an employee more so a Professor of the University. As a Professor/Dean of University he is well versed with Rules and Regulations of the University and he has to use democratic ways to present his grievances, if any. But keeping in view the principle of natural justice the Executive Council is of considerate opinion to give him a fair and final chance to represent himself. So, the Executive Council unanimously resolved that a detailed charge sheet be issued including all facts of the incidence happened on the last day of interview for the post of Associate Professor in Physical Education i.e. on 4.10.2020 and consequent instances.

Further resolved that the Vice-Chancellor is authorized to appoint an Enquiry Officer, preferably a Retired Session Judge/Additional District Session Judge for further enquiry in the matter.
