"All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall lay down and decide on annual basis, a predetermined and manageable number of M.Phil and doctoral students depending on the number of the available eligible Faculty Supervisors. A Supervisor shall not have, at any given point to time, more than Eight Ph.D. Scholars and Five M.Phil. Scholars."

The University started the M. Phil. in Management, Commerce, Computer Science & Applications, English and Physical Education and Ph.D. programmes in Management, Computer Science & Applications and Physical Education to promote the research and extension activities in the University with the following facilities and a perspective of following provisions:

That the University has well furnished Library facility and well established Computer laboratories to enhance the research activities

At present, the following faculties are eligible supervisor:

Management 01 Professor (on Deputation) and 02 Assistant Professors (Regular)

Physical Education

01 Professor (on Deputation)

Commerce

01 Associate Professor (on Deputation)
