NOTIFICATION

Minutes of the meeting of all Dean of Faculties/Chairpersons/Incharges of UTDs, CRSU, Jind held on 15.11.2021 at 01:30 p.m. in the Conference Hall of this University for re-opening of the University Campus for the students for physical/offline classes.

In the meeting, the orders of the Chief Secretary-cum-Chairperson, Executive Committee, Haryana State Disaster Management Authority issued vide No. DMC-SPO-2020/12069 dated 13.11.2021. After detailed deliberations, the following were decided:

1. The University will open for Physical (offline) classes for the 1st semester students from 22.11.2021. The students, who have been vaccinated for COVID-19 vaccine by at least one dose, will only be allowed to attend the classes in physical/offline mode.
2. The University hostels for boys and girl students will be opened with 50% capacity (one student in each room). The Hostel wardens will ensure that all residents and staff including mess staff have been vaccinated for COVID-19 vaccine.
3. The physical (offline) classes for the students of 3rd and 5th semester in courses where practical subjects are involved will be held from 22.11.2021. However, in courses, where practical subjects are not involved the classes for such students will continue through online mode.
4. All the teaching and non-teaching employees, including contractual and outsourcing employees, must get fully vaccinated, if not done already, as per orders of the Chief Secretary, Govt. of Haryana. All the Chairpersons/Directors/Principals/Branch Officers should advise such employees for taking or completing vaccination at the earliest.
