Sir/Madam,

In continuation to the Notification issued by Academic Branch vide Endst. No. CRSU/Acad/2021/4939-5105 dated 20-12-2021 regarding provisional promotion of the Students of Affiliated Colleges of Education of all Courses to their next semester/ year for the session 2021-22, the Schedule for submission of Continuation Returns is as under:

- a) All Affiliated Colleges of Education will have to completed the process of online submission of Continuation Return of only Eligible Students and submit the hard copy of the same in Registration Branch within 40 days without fine from the date mentioned in the above referred notification.
- b) For remaining Students with late fees, Continuation Return of only eligible students can be submitted online as well as to Registration Branch within 10 days each of the extended last date of promotion with late fee as fixed by the University from time to time.
- c) If any College submits the Online and Offline Continuation Return after 40 days in respect of (a) above and 10 days in respect of (b) above, Continuation Returns should be submitted with the following applicable fine:
