Note: - In case of Physical Education Courses, Physical Efficiency Test (PET) shall be conducted by the college concerned on the day of reporting of candidate and only those candidates who qualify the PET in the presence of the University observer shall be admitted and report of Physical Efficiency Test (PET) duly signed by Principal and observer must be submitted to the College Branch. The criteria for PET of B.P.Ed., D.P.Ed. & B.P.E.S. is at (Annexure-XXI).

If the seats after 1st and 2nd Counselling for B.Ed., B.Ed. (Special Education), D.P.Ed., B.P.Ed. and B.P.E.S. Courses under Self Financing Scheme (SFS) College of Education still remain vacant, then, 3rd counseling will be conducted by the Colleges at their own level only considering the students who had applied online.

Cut off date for eligibility will be the last date/time of online choice filling

Note: After subsequent counseling for vacant/leftover seats in Colleges of Education, no further counseling shall be conducted by the Colleges for admission and no College shall be allowed to make admission beyond 26.11.2022 even if seats remain vacant, to meet the minimum requirement of 200 days compulsory teaching as per NCTE norms. Further the Hon'ble Punjab & Haryana High Court, Chandigarh has decided in the CWP No.-25707 of 2015 that once the last date has been notified by the admission making authority, therefore, there would be no extension under any circumstances.
