

- Self-attested copy of relevant documents (Mark sheet of 10th, 12th, Graduation, Category certificate etc.).
- Proof of local guardian's residential address, i.e., self-attested photocopy of any one of the following: Voter I-Card/PAN Card/ Passport/ Driving License, Aadhar Card etc. and one copy of attested photograph.
