NOTIFICATION

In compliance of the decision of the Academic Council vide Resolution no. 49 of its 21st meeting held on 21.08.2023 and in anticipation approval of the Executive Coucnil, the Hon'ble Vice-Chancellor is pleased to approve the following recommendations of the Ph.D. Ordinance Committee:

(a) If the Research Supervisor of a Research Scholar has passed away or leaves the services of Chaudhary Ranbir Singh University, Jind before the Completion of the research work

OR

(b) If the Research Supervisor is unable to supervise the research work of Research Scholar or it becomes impossible for a Research Scholar to continue his/her research work with the Research Supervisor in case of extreme hardships/circumstances or on valid/genuine grounds.

OR

(c) If the Research Supervisor and the Research Scholar submit mutual consent in writing on valid/genuine reasons.

OR

(d) If a Research Supervisor Retires from his/her service before completion of Research Work.

In all above cases (except (d))the Hon'ble Vice Chancellor may allow to change the Research Supervisor/providing Co-supervisor where the change of Research Supervisor is in the interest of completion of research work of the Research Scholar on the recommendations of the Departmental Research Committee (DRC).

In case of (d) If the Research Supervisor Retire from his/her service before completion of Research Work the present Research Supervisor shall act as Co-supervisor and the a eligible teacher from the department concerned may act as Research Supervisor of the Research Scholar on the recommendations of the Departmental Research Committee (DRC).

The Supernumerary Seats already mentioned in the Ph. D. Ordinance and no need to any change.

Clause 11.9 of Ph.D. Ordinance effective w.e.f. the 2020-21 session and Clause 11.8 of Ph.D. Ordinance effective w.e.f. the 2022-23 sessions and reproduced as under:

11.9: Ph.D. student shall publish minimum two research papers (at least one should be published and other may be in press/accepted) in UGC CARE list journals from his/her research work. The research scholar shall invariably, be first author and supervisor/Co-supervisor/research guide shall be the corresponding author in atleast two research papers. In addition, a research scholar will make two paper presentations in conference/seminars before the submission of the thesis. The proof of publications and paper presentation must be appended with the thesis.

11.8: Ph.D. student shall publish minimum two research papers in UGC CARE list journals from his/her research work. The research scholar shall invariably, be first author and supervisor/Cosupervisor/research guide shall be the corresponding author in atleast two research papers. In addition, a research scholar will make two paper presentations in conference/seminars before the submission of the thesis. The proof of publications and paper presentation must be appended with the thesis.

The committee recommended that same may be replaced as under:

Ph.D. student shall publish minimum two research papers in UGC CARE/Peer reviewed/referred journals from his/her research work. The corresponding author in research paper shall be any co-author. In addition, a research scholar will make two paper presentations in conference/seminars before the submission of the thesis. The proof of publications and paper presentation must be appended with the thesis.

The Clause 13.1 of Ph.D. Ordinance effective w.e.f. 2020-21 session is re produced as under:

13.1: On completion of research work, candidate shall submit s synopsis to RAC. After approval of synopsis from RAC, seven copies of synopsis shall be submitted to DRC through supervisor (s) and a pre Ph.D. seminar has to be given by the candidate before DRC. The DRC will forwarded the synopsis with its recommendations to the PGBOS&R. A panel of atleast 10 experts in the area would be suggested by the Supervisor(s) and recommended by the RAC while forwarding the title and synopsis of the thesis. The panel so recommended would include alteast 4 examiners from outside Haryana.

The committee recommended that the same may be replaced as under:

13.1: On completion of research work, candidate shall submit a synopsis/summary with the title of thesis of Ph.D. thesis to RAC. After approval of synopsis/summary from RAC, five copies of synopsis/ summary shall be submitted to DRC through supervisor (s) and a prethesis submission Seminar has to be given by the candidate before DRC. The DRC will forward the synopsis/summary with its recommendations to the PGBOS&R. A panel of atleast 08 experts in the area would be suggested by the Supervisor(s) and recommended by the PGBOS&R while forwarding the title and synopsis/summary of the thesis. The panel so recommended would include at least 4 examiners from outside Haryana. (Only for Faculties of Physical and Life Sciences).

13.1 (a):

Prior to the submission of the thesis, the Research Scholar shall present a Pre-Thesis submission seminar in the Department that shall be open to all Faculty Members and Research Scholars, for getting feedback and comments, which shall be suitably incorporated into the draft thesis under the advice of the Supervisor. The notice of the pre-thesis submission Seminar shall be issued by the Chairperson of the Department under intimation to the Vice Chancellor. On successful presentation of the Pre-Thesis Seminar, the Research Scholar is required to submit the thesis within three months from the date of the Pre-submission Seminar, failing which he/she shall have to repeat the pre-submission seminar. The DRC will forward the synopsis with its recommendations to the PGBOS&R. A panel of at least 08 experts in the area would be suggested by the Supervisor(s) and recommended by the PGBOS&R. The panel so recommended would include at least 4 examiners from outside Haryana. (Other than Faculties of Physical and Life Sciences).

The above amendments will be applicable with effect from the respective session(s).
