Infinites of the meeting of the Deans Committee held on 17.08.2022 at 11:00 PM in the O/o Dean Loadenic Affairs, CRSU, Jind regarding draft the rules for empanelment of the Part-time Teachers in Luive saity teaching departments for the academic session 2022-23. The following were present:-

1. Prof. S K Sinha, Dean Academic Affairs, CRSU, Jind

- 2. Dr. Anand Kumar, Dean of Colleges & Dean, Faculty of Physical Sciences, CRSU, Jind
- 3. Dr. Sunil Phougat, Dean, Faculty of Social Sciences, CRSU, Jind
- 4. Dr. Kuldeep Nara, Dean, Faculty of Education, CRSU, Jind

The committee has gone through the KUK guidelines for the engagement of the part-time teachers as the same has also been followed by this University and recommended the following fresh guidelines of CESSU Jind:-

- 1. The Chairpersons of the University Teaching Departments will submit the requirement of Parttime Teachers to the-Competent Authority after consultation with the Dean of Faculty with
 proper justification of uncovered workload/ specialization before starting the new academic
 session. The concerned teaching department may invite the applications from the candidates on
 University Website as well as on the department notice board.
- 2. The candidates will submit their prescribed application form with the copy of academic proofs/documents to the Chairperson of the concerned University Teaching Department within the stipulated time.
- 3. The recommendations of the Part-time teachers will be made by the following committee as per the selection criteria at Annexure-A as well as through the presentation/ teaching skills before the committee:-
 - 2) Denn Academic Affairs, CRSU, Jind
 - b) Dean of concerned faculty
 - c) Chairperson of the concerned teaching department
 - d) One teacher regular/contractual of the concerned teaching department if not available then outside expect of the concerned subject with the permission of the Competent Authority.
- The Fart-time teachers will be empanelled for a particular academic session (semester to semester) @ Rs. 750/- per lecture to a maximum of Rs. 34,000/- per month.
- 5. The Part-time teachers will not be assigned the workload of more than 14 hours per week.
- 6. The Chairperson/Dean of concerned faculty will not issue any engagement letters or relieving cidens at their own level to any empanelled Part-time teachers.

Non NET/Ph.D. candidates will be empanelled as Part-time teachers where NET/Ph.D. candidates are not available @ Rs. 500/- per lecture to a maximum of Rs. 25,000/- per month.
