B.A.LL.B. (HONS) FIVE YEAR INTEGRATED PROGRAM SEMESTER SYSTEM

- 1. The duration of the program shall be five academic years, divided into ten semesters. The examination for the I, III, V, VII and IX semesters shall ordinarily be held in the month of December/January and for the II, IV, VI, VIII and X semesters, in the month of May/June on such dates as may be notified by the Controller of Examinations.
 - A Supplementary examination for odd and even semesters shall be held along with their regular odd and even semester examinations. However, the supplementary examination for IX, X semesters shall be held simultaneously after every six months.
- 2. The Schedule of dates fixed in accordance with clause 1 above shall be notified by the Controller of Examinations.
- 3. The last date (s) by which the examinations form and fees must reach the Controller of Examinations shall be as per schedule issued by the Controller of Examinations from time to time.
- 4. (i) After completion of all ten semesters (First to Tenth semesters), the candidates may be awarded the Bachelor's degree in Hons. named as B.A. LL.B (Five year integrated program).
 - (ii) In B.A.LL.B. (Hons.) 5 year program, the exit is not allowed by the Bar Council of India. Hence, the degree of B.A. LL.B. (Hons.) only shall be awarded after the completion of the 5 year program.
- 5. The examination schedule containing the dates of receipt of examination forms with and without late fee shall be notified by the Controller of Examinations from time to time.
- 6. A person who has passed the 10+2 examination from Haryana Board or any other examination recognized by the Chaudhary Ranbir Singh University, Jind as equivalent there to, shall be eligible for admission. The detailed eligibility conditions e.g. percentage of marks in the qualifying examinations, subject(s) combination etc. shall be notified in the Admission Brochures approved by the Academic Council from time to time.
 - 6.1 Those who have done graduation or post graduation shall not be eligible for 5 year Integrated program.
 - 6.2 The Candidates who are placed under compartment in the qualifying examinations shall not be allowed admission to the program.

Note:

The candidate admitted to B.A.LL.B. (Hons.) 5 year program shall not be allowed to switch over to any other program, otherwise the candidature for B.A.LL.B. (Hons.) program shall be cancelled forthwith.

7. The minimum pass marks for passing any examinations shall be 40% in aggregate of each theory paper and internal assessment.

- Each written paper for the respective semester Examination shall be set and evaluation of the answer books shall be done as per the University rules.
- The internal assessment in each theory paper of B.A. LL.B. (Hons.) 5 year integrated program shall be as under:

0.5 marks Attendance more than 75-80

- 10. The assessment of sessional/practical work (Project, Seminar/Moot Court, Mid-Term Tests, etc.) shall be made by the teacher, teaching the paper.
- 11. Every candidate shall be examined in the subject(s) as laid down in the syllabus and scheme of examination prescribed by the Academic Council from time to time. The fail/re-appear candidates will also appear in the examination as per syllabus applicable to regular students of that semester.
- 12. 20% marks in each written paper (excluding viva-voce), shall be assigned for internal assessment. The Head of the Department shall forward the internal assessment marks awarded by the concerned teacher on the basis of class test, written assignment and its Presentation/Seminar and attendance in the classes etc. to the Controller of Examinations as per the following schedule:
 - (i) The Internal Assessment/Sessional marks should be supplied by the Heads of the Departments as per schedule issued by the Controller of Examinations from time to time.
 - (ii) Thereafter, a late fee prescribed by the University from time to time per candidate per subject shall be charged from the concerned teacher.
 - (iii) No internal Assessment/Sessional marks shall be entertained if the same are received in the University after 30 days of the declaration of results. However, Vice-Chancellor may condone the delay with late fee after taking into consideration the merit of each case.
- 13. The concerned teacher will preserve the records on the basis of which the Internal Assessment awards have been prepared for inspection, if needed by the University, up to three months from the date of declaration of each semester examination results.
- 14. The candidate will be allowed to appear in the examinations if he/she meets the following requirements:-

- a) Bears a good character
- b) Has been on the rolls of the Department during the semester.
- c) Has attended not less than 75% of lectures delivered in each theory paper as well as practicals (the program to be counted up to the day before the commencement of the examination). Relaxation in shortage of lectures up to 10% will be allowed by the Head of the Department on the following grounds:
 - (i) self-illness;
 - (ii) illness/death of parents, brother, sister or any other close family member;
 - (iii) Any other reason beyond the control of the student to the satisfaction of the Head of the Department.

Provided that if the percentage of attendance is deficient on account of:

- (i) Participation in Inter-University, University or Inter-Collegiate Sports
 Tournaments/Youth Festivals/University Level Debates, National and International
 Tournaments, with the previous sanction of the Head of the Department.
- (ii) Attendance of the N.C.C Camps or University Educational Excursions or other extracurricular activities, certified by the Head of the Department.
- (iii) Attendance at Mountaineering Program:
 - (a) By N.C.C. students;
 - (b) By students sent by the Youth and Cultural Affairs Department;
- (iv) Voluntary donation of blood certified by a Government Doctor of Gazetted rank or University Medical Officer.
- (v) Attendance and/or participation in the All India Moot Court/Debate Competitions;
- (vi) Attendance at the extension lecture (s) organized by the National Institute of Law/Department of Law.

Credit may be given for the number of days on which lectures were delivered or sessional/practical work done during the period of attendance or participation aforesaid, provided that the total period of absence shall not exceed 11 days in a semester and that for (iv) above shall not exceed 2 days.

- 15. The medium of instruction shall be English. However, the medium of examination shall be English/ Hindi. However, question paper will be supplied in English only.
- 16. The examination fee to be paid by the candidate for each semester shall be prescribed by the University from time to time.
- 17. The candidate shall be treated as promoted to the next semester/class automatically subject to fulfillment of conditions as laid down in clause-14 of the Ordinance.

However, promotion to 7th semester will be allowed only when he/she has cleared the 1st Year (1st and 2nd semesters).

- 18. A candidate who fails to pass or having been eligible, fails to appear in any semester examination will be allowed to clear the re-appear paper(s) of result after passing a semester examination within a period of Seven (7) years from the date of admission.
 - While re-appearing to pass a semester examination, the candidate will be exempted from reappearing in the papers/ practical in which he/ she secured 40% pass marks.
- 19. Improvement in any examination of B.A. LL.B. (Hons.) 5 year program shall be allowed only after the successful completion of the degree and within two years from the date of its completion.
- 20. The Internal Assessment awards as well as viva-voce awards of a candidate who fails in any semester examination shall be carried forward to the next examination.
- 21. Soon after the termination of the examination, the Controller of Examinations shall declare the result as early as possible.
- 22. The list of successful candidates after the X semester (10th semester for B.A.LL.B. (Hons.) 5 year program) examination shall be arranged as under in three divisions on the basis of the aggregate marks obtained in I to X semester examinations taken together, and the division obtained by the candidate will be stated in his/her degree:-

a) Those who obtain 60% or more marks

First Division

b) those who obtain 50% or more marks but less than that 60% marks

Second Division

c) Those who obtain less than 50% marks

Third Division

The candidates who pass the examination at the first attempt and with minimum duration of the program after obtaining 75% or more marks of the total aggregate shall be declared to have passed with 'Distinction'.

Note:

There shall be no lateral entry on the plea of graduation or exit by way of awarding a degree splitting the integrated double degree program, at any intermediary stage.

- 23. The grace marks will be allowed as per University rules.
- 24. The Training Report / Field Report/ Project Report/ Moot courts etc. wherever prescribed in the syllabus/ scheme of examination and required to be submitted to the University must reach in the concerned office within 20 days after the commencement of the theory examinations.
- 25. Notwithstanding the integrated nature of the program, which is spread over more than one academic year, the Ordinance in force at the time a student joins the program shall hold good only for the
