- c) If any College submits the Offline Continuation Return after 40 days in respect of (a) above and 10 days in respect of (b) above, Continuation Returns should be submitted with the following applicable fine:

2.	 (i) For 8-14 days late after expiry of norma due date (ii) For 8-14 days late after expiry of extended due date 	with maximum of Rs. 50,000/-
