## **ORDINANCE**

(W.e.f. 2025-26)

### **MASTER OF ARTS Yoga Science (M.A. Yoga Science) (Scheme-Q)**

(Ordinance prepared as per the provisions given in “Curriculum and Credit Framework for Post Graduate Programmes” as per NEP-2020)

#### **1. TITLE AND COMMENCEMENT**

- a) The ordinance shall be called as Ordinance for **Master of Arts Yoga Science (M.A. Yoga Science)** programme.
- b) The nomenclature of the programme shall be Master of Arts in Yoga Science i.e. M.A.(Yoga Science) which shall be offered as per **UGC NEP-2020 “Curriculum and Credit Framework for Post Graduate Programmes”**. The objective of the programme is to prepare qualified and competent teacher educators and educational entrepreneurs.
- c) The ordinance shall be applicable to M.A. (Yoga Science) programme offered by Department of Yoga Science. It will come into force from the Academic Session 2024-25 and shall replace the existing ordinance.

#### **2. DURATION OF THE PROGRAMME**

- 1) According to the NEP-2020, the Department will have the flexibility to have Different designs of M.A. (Yoga Science) programme based on multiple-entry and exit system. The duration of the programme leading to the two-year Degree of Master of Arts Yoga Science i.e. M.A. (Yoga Science) shall be of four Semesters, that is, two academic years.
- 2) An academic year shall be divided into two semesters namely July to December and January to June. Each semester shall be of 12-13 weeks.
- 3) A student will be awarded with **Master Degree in Yoga science** after successful completion of two year P.G. Programme by earning atleast 108 credits.
- 4) A student will be awarded a Master’s Degree in Yoga Science upon successful completion of a one-year postgraduate programme, earning at least **52 credits**, under the **lateral entry** scheme.

This option is available from the **academic session 2024–25** for:

- Students who have completed a **one-year P.G. Diploma in Yoga Science**.
  - Students who have completed a **4-year undergraduate programme with Honours or Honours with Research in Yoga**.
- 5) A student can take exit after the successful completion of first two semesters (one year) after earning atleast 56 credits with the completion of internship, and then a Post Graduate Diploma in Yoga Science shall be awarded to that candidate.
  - 6) A student can complete a 2-year PG programme within four years. A student, who fails to pass the whole examination(s) of a 2- year PG programme within four years of admission

but has passed all courses of first two semesters and also has completed the requisite internship of the programme, shall be awarded with Postgraduate Diploma on the basis of courses completed and credits earned, if otherwise eligible.

- 7) A Student can complete a 1-year PG programme within two years.
- 8) Each student will have to open an account on Academic Bank of credit (ABC) or APPAAR portal through their concerned DCI if he/she does not have an active ABC account. At the end of each semester, credit earned by the student will be uploaded in his/her respective ABC account. A student registered in ABC account for a programme will be allowed to complete the respective programme within four years or as notified from time to time.

### **3. ADMISSION PROCEDURE AND ELIGIBILITY**

#### **3.1 Admission Procedure**

- i. A candidate shall apply as mentioned in the information bulletin/prospectus for admission in M.A. Yoga Science programme along with registration fee and the manner prescribed by the university from time to time.
- ii. Admission shall be made on the basis of the Academic Merit/Entrance Test or through any other mode to be decided by the competent authority of CRSU, Jind from time to time.
- iii. The programme fee to be paid by the candidate shall be as such as prescribed by the University / Government of Haryana from time to time.
- iv. Every student admitted to the programme shall be enrolled / registered in the university through the procedure prescribed by the competent authority from time to time.
- v. Married female candidates shall have to submit a certificate from SMO/MO of the Civil Hospital that she is not in the family way, physical fitness certificates along with an undertaking that if during the course of study, it is found that she is in family way, her admission would be liable to be cancelled IPSO-FACTO and all dues paid by her shall be forfeited.
- vi. Every student admitted to the programme shall have to submit a physical/medical fitness certificate from SMO/MO of the Civil Hospital.
- vii. Dress Code for Practical Classes will be decided by the Department.

#### **3.2 Eligibility for admission**

- a) Bachelor Degree in any discipline or any other examination recognized as equivalent there to with at least 45% marks in aggregate.
- b) There will be no rounding off percentage to determine the eligibility for admission to various programme. Candidate who has placed under compartment is not eligible for admission to any programme.

#### **3.3 Reservation**

The reservation policy of the Government of Haryana, as amended from time to time, for admission to government/government-aided educational institution shall be followed.

### 3.4 Intake

Intake for admission to M.A. (Yoga Science) programme will be decided by the staff council of the Department prior to the start of the new Academic Session.

### 3.5 Promotion of Candidate

There will be no condition of passing papers for promotion from odd semester to even semester in an academic session. To qualify for admission to semester III of the programme, the candidate must have **Passed 50% of total papers of two Semesters in the First year.**

## 4. PROGRAMME STRUCTURE AND TYPES OF COURSES

1. The programme shall have structure as per NEP-2020 “Curriculum and Credit Framework for Post Graduate Programmes” Framework-2, Scheme Q as adopted by Department of Yoga Science, Chaudhary Ranbir Singh University, Jind.
2. The Core courses (CC) will be studied compulsorily by a candidate as a core requirement of the discipline.
3. The Discipline Specific Elective Courses (DEC) are elective in nature which shall enable the students to have specialized understanding of a course.
4. Practicum courses (PC) will provide a context of hands on or practical experiences of conceptual knowledge and will enhance their professional skills.
5. Every student of M.A. (**Yoga Science**) Programme shall be required to undergo one Internship course of 4 Credits of 4 weeks duration during summer vacation after the II<sup>nd</sup> Semester examination. Internship can be either for enhancing the employability or for developing the research aptitude.
6. A student will opt for an Open Elective Course (OEC) of 2 Credits from a pool of courses, and offered by the University, other than its subject in the 3<sup>rd</sup> Semester.
7. The Department shall offer two types of schemes in IV<sup>th</sup> semester as given in the scheme of examination. The staff council of the department will decide and declare the number of seats for Dissertation Work of 12 Credits in the IV<sup>th</sup> Semester at the beginning of the 3<sup>rd</sup> semester depending upon the availability of infrastructure, faculty, and expertise in the area of specialization.
8. The programme structure of M.A. **Yoga Science** programme shall be approved or modified by the Post Graduate Board of Studies and Research (PGBOS&R) from time to time as per need and requirement.

## 5. WORKING DAYS AND ATTENDANCE



- I. The programme shall be conducted for at least 90 working days in each semester exclusive of the period of examination and admission. The institution shall work for a minimum of thirty six hours in a week, during which physical presence in the institution of all the teachers and students is necessary to ensure their availability for advice, guidance, dialogue and consultation as and when needed.
- II. The minimum attendance of enrolled students shall have to be 75% for all theory and practicum, and 100% for internship. However, 10% attendance may be condoned by the Head/Chairperson on genuine grounds like participation NCC/NSS camps on working days, participation in university games/youth festivals on working days, prolonged illness duly certified by the Registered Medical Practitioner, or any other cognate reason up to the satisfaction of Head/Chairperson of the Department.
- III. If a student fails to attend classes continuously for seven teaching days his/her name shall be struck off from the rolls. He/she may get readmission with the permission of the chairperson/principal within the seven working days of striking of the name with a readmission fees of Rs. 1000/-. The student may be readmitted twice in an academic year. In continuation after the last date of readmission. The readmission will be allowed by Hon'ble Vice-Chancellor. However, if the name of student struck off third time in an academic year his/her admission shall be cancelled de-novo.
- IV. Students have to ensure their 100% presence in Departmental Programmes i.e. workshop, seminar, conferences and all other social activities.

## **6. EXAMINATION AND EVALUATION**

1. The examination for the degree of Master of Arts in Yoga Science shall be held in four semesters to be called Semester-I, II, III and IV. The examination for the I and III semester shall be held in the month of November/ December and for the II and IV semesters in the month of April/May or on such other dates as may be fixed by University.
2. Admission forms and fees for Semester-I, II, III and IV examination should reach to the Controller of Examination, C.R.S.U., Jind on dates as notified from time to time. No examination form will be accepted after the notified date.
3. Each student shall be examined in the course(s) to help their progression through the programme as laid down in the scheme, syllabus and learning outcomes through a system of Continuous Comprehensive Assessment (CCA) using a mix of Internal and End-Term evaluation.
4. Internal Assessment will be broadly 30% of the total marks and weightage of 70% shall be given to evaluation of End-Term examination(s).
5. Internal Assessment (30%) shall be broadly based on the defined components as available in Scheme of M.A. Yoga Science under Distribution/Criteria of Internal Assessment Table-1 to 5.
6. Internal and External Assessment Marks will be further distributed as given in the scheme of examination.
7. Every candidate shall be examined according to the scheme

- approved by the Academic Council from time to time.
8. The medium of examination shall be English/Hindi. The question-papers shall be set both in English and Hindi. The candidates shall write their answers either in English or Hindi.
  9. The internal assessment marks obtained by the candidates in each semester, duly countersigned by the Chairperson of University Teaching Department shall be forwarded to the Controller of Examination at least 15 days before the commencement of the semester-end examination. The Chairperson of the University Teaching Department concerned shall preserve the record on the basis of which the internal assessment awards have been prepared, for inspection if needed by the University up to six months from the date of declaration of the semester result. The grace marks shall be allowed according to the General Ordinance relating to “**Award of Grace Marks**” of the university.
  10. The end term examination will be held on such dates as may be notified by the Controller of Exam.
  11. All courses of M.A.Yoga Science programme shall have a specified number of credits in each semester. To pass in any course i.e. core, elective, open elective, practicum, internship, dissertation etc., the enrolled student must secure 40% marks in theory (external) as well as practicum examination. If a candidate fails to secure minimum pass percentage, he/she will be placed under re-appear category.
  12. The examination of re-appear courses of odd semester will be held with regular examination of the odd semester and the examination of re-appear courses of even semester will be held with regular examination of the even semester. A Candidate placed under reappear in any paper, will be given two chances to clear the reappear, which shall be available within consecutive two years/chances i.e. to pass in a paper the candidate will have a total of four chances. One as regular student and three as reappear candidate.
  13. In case of reappear in external exams, the internal assessment marks shall be carried forward.
  14. If a student fails to appear in the internal assessment due to unforeseen situations, he/she may be allowed to submit the same with the permission of Chairperson of the Department on the satisfaction of the reason mentioned by the student for not appearing in the regular internal examination.
  15. In case of Dissertation, the supervisor concerned shall approve the topic of dissertation or the Department may engage external experts for this purpose. The external and internal examiners will conduct the Viva-Voce of the dissertation/practicum jointly and both will award marks/credits.
  16. Those candidates, who opt for the Scheme-1 in IV<sup>th</sup> semester, shall be required to submit three copies of dissertation as per dates notified by the branch concerned.
  17. Those candidates, who opt for the Scheme-2 in IV<sup>th</sup> semester, shall be required to submit one copy of Practicum file as per dates notified by the branch concerned.
  18. The last date for the receipt of dissertation/practicum file in the

commencement of semester examination. In exceptional cases; the Vice-Chancellor shall have the power to extend the last date on the recommendation of the Chairperson of the University Teaching Department.

19. If a candidate fails to submit the Dissertation/practicum even upto period extended by the Vice-Chancellor, he/she will be considered as absent in Dissertation/practicum course and his/her result shall be declared under re-appear category. Special permission for the same shall be taken from the competent authority to complete the dissertation/practicum. Dissertation Fees decided by the Controller of Exam.

**7. RESULT**

The result will be declared provisions made in “Curriculum and Credit Framework for Post Graduate Programmes’ by Chaudhary Ranbir Singh University, Jind.

**8. AWARD OF DEGREE**

The degree of Master of Arts in Yoga Science i.e. M.A. Yoga Science in the Faculty of Education will be conferred upon those candidates who has pursued a regular programme of study for two academic years and has passed all the courses with required credits as given in the scheme of examination. If a candidate takes exit after successfully completion of the first year, he/she will be awarded **Post Graduate Diploma Yoga Science**.

**9. INTERPRETATION AND AMENDMENT (S)**

In any matter of interpretation of the clauses of this ordinance, the matter shall be referred to Vice-Chancellor and the decision of the Vice-Chancellor shall be final. The Ordinance may be amended by the Academic Council and the amended Ordinance, if any, shall be applicable to all the students. If any question arises related to the matters not covered in the clauses, the relevant provision(s) made in appropriate Rules/Regulations/Ordinance/Notifications issued by the university shall prevail.

**Note: If any rule position was left in above may be procured from the general ordinance of PG Programme.**
