

Instructions:-

1. A candidate who has already passed the examination for the degree of Bachelor of Education (B.Ed.) from Chaudhary Ranbir Singh University, Jind may be allowed to appear in any other pedagogy subject offered by the University, as an additional subject, other than those in which he/she has already passed. He/She shall be admitted to the examination on submission of application on the prescribed form and on payment of admission fee as prescribed by the University. The candidate must fulfill the following conditions:-

- In the case of a Pedagogy subject, He/She must have already passed the degree examination (graduate of post graduate)
 - In addition to the Written Paper of the Pedagogy subject the candidate shall undergo a practical test in the pedagogy of the additional subject taken by him/her.
 - Such candidate will be required to register themselves with any B.Ed. College of this University by paying a fee of Rs. 1000/- to concerned college/institution by 20.04.2026 i.e. last date for submission of Examination forms without late fee.
 - The candidate must mention his/her B.Ed. 2 year roll number on the examination form.
2. Only the examination forms of eligible candidates will be accepted through the online mode on the University portal.
3. The online portal will open from 06.04.2026.
4. The examination form fee for additional subject of B.Ed. is Rs. 1500/-


